## **PROJECT SCOPE:**

The project consists of asphalt topping, and striping of East Georgia Street and Burns Avenue.

A more detailed scope of work items per street is listed below:

<u>EAST GEORGIA ST</u> FROM THE INTERSECTION OF WILLIAMS AVENUE APPROX. 755 LF TO THE ORCHARDS SUBDIVISION ENTRANCE:

- APPLY 2" OF ASPHALT SURFACE TOPPING (APPROX. 220 TN)
- PAINT DOUBLE YELLOW LINE (APPROX. 755 LF)

<u>BURNS AVENUE</u> FROM THE INTERSECTION OF HARRIS STREET APPROX. 645 LF TO THE INTERSECTION OF W. GEORGIA STREET:

- APPLY 1½" OF ASPHALT SURFACE TOPPING (APPROX. 130 TN)
- REPAINT 2 STOP BARS (APPROX. 24 LF)
- REPAINT CROSSWALK AT HARRIS STREET (APPROX. 25 LF)
- PAINT DOUBLE YELLOW LINE (APPROX. 645 LF)

Bidders are required to provide lump sum bids for this project scope.

The Sealed Bid will be received and opened at Pine Mountain Town Hall, no later than 10:00 a.m. on Monday, August 4, 2025. Any packages received after 10:00 a.m. will not be considered by the OWNER. Bids will be evaluated by the OWNER, and the project award is anticipated the week of August 11, 2025.
