June 7, 1993

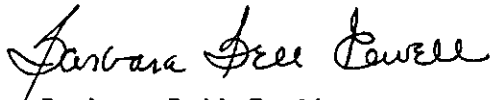
The City Council of the Town of Pine Mountain sat in a called meeting on June 7, 1993 at 5:30 P M in the City Hall.

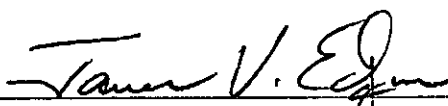

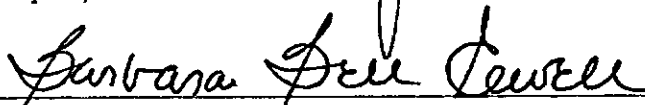
WHEREAS, the public, in part, for the April 22, 1993 Draft Plan Public Hearing received a totally positive public review; and,

WHEREAS, the Town of Pine Mountain of Harris County is in full agreement with and approves the Draft Solid Waste Management Plan with minor corrections.

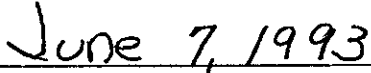
