

ACTS OF THE COUNCIL
September 13, 1993

The Town Council of the Town of Pine Mountain met in regular session on the evening of September 13, 1993 at seven o'clock P. M. in the Town Hall.

Mayor James V Edgar presided with Councilmen J Richard Beall, Franklin D Boykin and Vance C Smith, Sr present.

Acts of the Council:

Upon motion by Mr Smith, seconded by Mr Boykin and agreed upon by all, the Acts of July 12, 1993 were approved as written.

Special Use One Percent Sales Tax:

Upon recommendation by Mayor Edgar, a motion was made by Mr Smith to apply for the amount of \$421,000.00 to be added to the Special Use Sales Tax referendum the Harris County Board of Commissioners is planning to place before the voters on November 2, 1993. The amount to be requested is broken down in the following manner: \$ 288,000.00 for beautification and \$133,000.00 for the purchase of a new fire truck. The motion was seconded by Mr Boykin and agreed upon by all.

Application - Beer and Wine License - Piccolo Restaurant - Second Reading:

Mayor Edgar gave the second reading of an application by Piccolo Restaurant for a beer and wine license.

Mr Boykin made a motion that the license be granted.

The motion was seconded and the vote was unanimous.

Election Ordinance - Second Reading:

Mayor Edgar presented the Election Ordinance for the second reading.

Mr Beall made a motion that the ordinance be adopted.

Mr Smith seconded the motion and the vote was unanimous.

Local Development Grant:

Mayor Edgar announced to the Council that Precision Planning, Inc is in the process of preparing an application for another Local Development Grant for beautification. The cost for the application will be \$500.00.

Mr Boykin made a motion that the application be sent to the Georgia Department of Community Affairs for grant consideration.

Mr Beall seconded the motion and the vote was unanimous.

Request Beer and Wine Sales - Callaway Resort, Inc:

Mayor Edgar read a letter from Mr Scott Anderson requesting permission to sale alcoholic beverages on the Sunday of the Buick Southern Open at the golf clubhouses only.

Mr Boykin made a motion that permission be granted to do so.

Mr Smith seconded the motion.

Mr Boykin and Mr Smith voted in favor of the motion.

Mr Beall voted in opposition to the motion.

Paving of Gardenvue:

Mayor Edgar reported that letters have been sent to the Georgia Department of Transportation requesting funds and/or assistance for the paving of the south portion Gardenvue Drive.

Pine Mountain Tourism Contract:

Upon motion by Mr Boykin, seconded by Mr Beall and agreed upon by all, a contract with Pine Mountain Tourism for F/Y 93/94 was adopted.

Pine Mountain Gymnasium:

Mr W Kendrick Askew appeared before the Council to report on the meetings of the committee formed for the study of renovation of the gymnasium.

There being no further business, the meeting was adjourned.
