BUDGET FY 95/96

Mr Holladay made a motion to approve the prepared budgets for the Fiscal Years 1995/1996.

Ms Sullivan seconded the motion.

Mr Beall, Mr Boykin and Mr Smith voted in favor of the motion.

MINUTES

Ms Sullivan made a motion that the minutes of the Public Hearing and Council Meeting held on May 8, 1995 be approved as written.

Mr Ken Askew appeared before the Council to present a report on the Chipley School reunion recently held in the gymnasium.

Mr Askew presented a check in the amount of \$4,846.73 to be earmarked for the gym renovation project. The money was collected by the Reunion '95 Committee through ticket sales.

WATER RATES

Mayor Edgar presented a formula for a rate increase in the water and sewerage department.

CABLE FRANCHISE
