

ACTS OF COUNCIL

Mr Robert McGee presented the Mayor and Council with a trophy that was won by the youth.

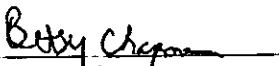
Mr McGee reported to the Mayor and Council some of the activities that the youth will be doing in the summer.
