Mr Champion discussed with the Mayor and Council about leasing the land where the Police Department is located to the Post Office.

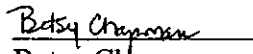
Andy Kober invited the Mayor and Council to the Fire Department lunch on December 10, 2000 at 1:00 P.M.

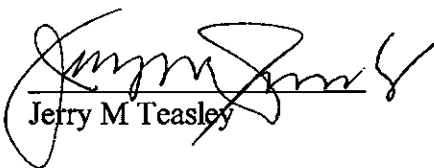
ADJOURMENT

Mrs Pierce seconded the motion.

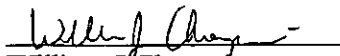
