Mayor Teel presented the 1st reading for beer and wine license for MoneyBack #25.

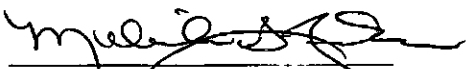

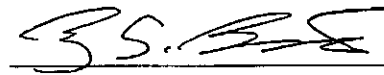
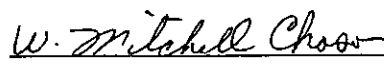
ADJOURNMENT
