ACTS OF COUNCIL

PINE MOUNTAIN HERITAGE

Mrs Dawson came before the Council requesting permission to apply for a second grant from DCA for \$50,000.00. This grant would be used to reconstruct the sidewalk (additional 2 ft) in front of Pine Mountain Tourism to the end of North Commerce Avenue. The Town provide labor to tear out the existing sidewalk on an in-kind basis.

Mr Chason made a motion that Pine Mountain Heritage apply for the grant and the additional 2 ft be added. Also, that Mayor Teel be allowed to execute the necessary paperwork.
