

**ACTS OF COUNCIL
OCTOBER 8, 2001**

The Mayor and Council of the Town of Pine Mountain sat in a regular session on the evening of October 8, 2001 at 7:02 P.M. in the Town Hall.

Mayor Joe D Teel, Jr presided with Councilperson W Mitchell Chason, Jerry M Teasley, Tamara M Pierce, Barbara Bell Ewell and Benny S Burdette in attendance.

ACTS OF COUNCIL

Mr Chason made a motion that the Acts of Council for the September meeting be approved as written.

Mrs Pierce seconded the motion.

Mr Burdette voted in favor of the motion.

Mr Teasley and Ms Ewell were not present at the September meeting.

FINANCIAL REPORTS

Mayor Teel presented the financial report for September.

PINE MOUNTAIN TOURISM

Ms Arnold presented the monthly report.

PINE MOUNTAIN HERITAGE

Mrs Dawson came before the Council requesting permission to apply for a grant from DCA for \$10,000.00 that would be matched from Pine Mountain Tourism. This grant would be used to reconstruct the sidewalks in front of Main Street Emporium and Pine Mountain Printing.

Mrs Dawson requested that Mayor Teel be allowed to execute the necessary paperwork and that the Town provide labor and machinery to tear out the existing sidewalk on an in-kind basis. The grant requires that the Town must either provide dollars or in-kind work on the project. Mayor Teel also advised the Council that a separate checking account needed to be opened for this project.

Mrs Pierce made a motion that Pine Mountain Heritage apply for the grant and that Mayor Teel be allowed to execute the necessary paperwork, with a separate checking account be opened by Betsy Chapman.

Mr Teasley seconded the motion.

Ms Ewell and Mr Burdette voted in favor the motion.

Mr Chason voted against the motion.

PINE MOUNTAIN CHAMBER OF COMMERCE

Mrs Dawson reminded the Council of the "Old Fashion Market Day" being held on October 13, 2001. A portion of Commerce Street will be closed.

PINE MOUNTAIN CHRISTMAS PARADE

Mrs Dawson advised the Council and Mayor that the Pine Mountain Christmas Parade will be held on December 1, 2001 (Saturday) at approximately 1:00 P.M.
