Ms Pierce made a motion to adjourn the meeting.

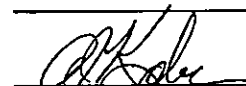
Mr Chason seconded the motion.

Mr Burdette, Ms Ewell and Mr Kober voted in favor of the motion.

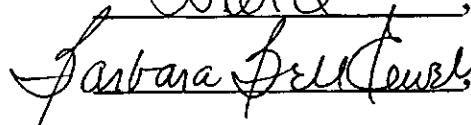
