PINE MOUNTAIN TOURISM

BOYS & GIRLS CLUB STATUS

Mr John Magazu, Harris County Recreation Director, advised the Mayor and Council that the County has offered the Carver Resources Center for the boys & girls club. The County will pay for the water, heating and maintenance of the building.

Wally West stated that it was going to take the local support for this to happen. A budget of approximately \$50,000 would be needed for the Boys & Girls Club. The fee for the program will be \$50.00 per child per ~~week~~ *year*.

PURPLE COW CAFE (BEER & WINE LICENSE)(ROGER BRYANT)-1st READING

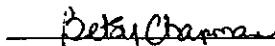
Mayor Teel presented the 1st reading for beer and wine license application for Purple Cow Cafe in the name of Roger Bryant.

Ms Pierce seconded the motion.

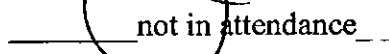
Mr Trott voted in favor of the motion.
