Mr Teasley seconded the motion.

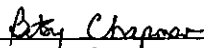
Mr Trott, Ms Ewell and Mr Kober voted in favor of the motion.

ADJOURNMENT

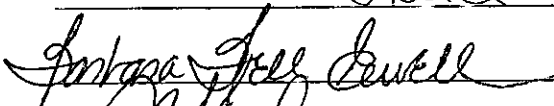
Ms Ewell made a motion that the meeting be adjourned.

Mr Teasley seconded the motion.

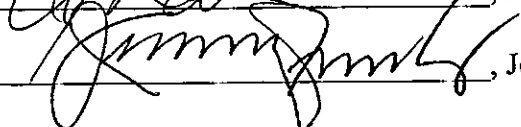
