BEER/WINE LICENSE (Kit's)(R.H. "Sandy" Reames, Jr.)-1st Reading

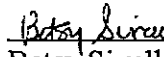
Mayor Teel presented the 1st reading on the beer and wine license application for Kit's in the name of R.H. "Sandy" Reames, Jr.

ADJOURNMENT

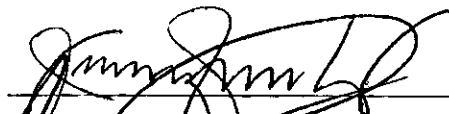
Ms Pierce made a motion that the meeting be adjourned.

Mr Teasley seconded the motion.

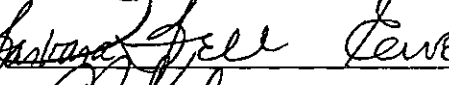
Mr Trott, Ms Ewell and Mr Kober voted in favor of the motion.
