Ms Teasley advised the Mayor and Council they would have a Bluegrass Band and wanted to make sure that it would be okay with the noise ordinance.

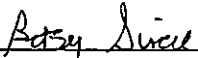
Mayor Teel suggested that she let the people around the area know that this will be taking place.

**ADJOURNMENT**

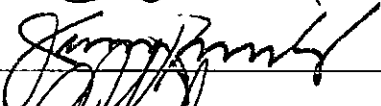
Mr Teasley made a motion that the meeting be adjourned.

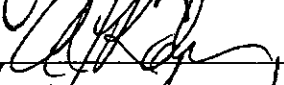
Ms Pierce seconded the motion.

Mr Trott, Ms Ewell and Mr Kober voted in favor of the motion.

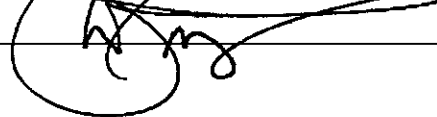
