Mr Teasley seconded the motion.

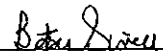
Ms Ewell, Ms Pierce and Mr Trott voted in favor of the motion.

ADJOURNMENT

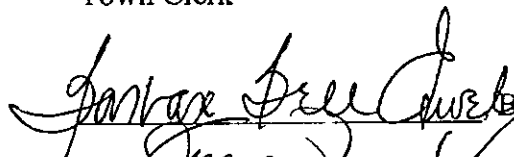
Ms Pierce made a motion that the meeting be adjourned.

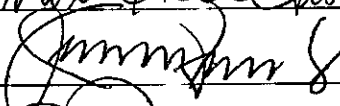
Mr Teasley seconded the motion.

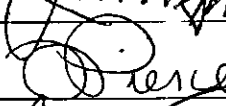

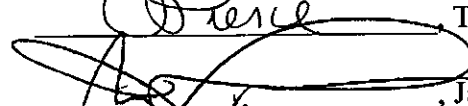


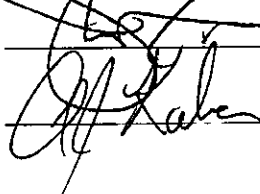
