ACTS OF COUNCIL

LAWN MAINTENANCE CONTRACT

Mr Teasley made a motion to approve the low bid from Williams Enterprises Lawn Services at \$18,300.00 per year.

SPEEDING PROBLEMS ON HIGHWAY 18 INSIDE CITY LIMITS-Bo Hastey

Mr Hastey requested that the speed limit be changed from 35 mph to 25 mph. Mayor Teel will contact the DOT office. Mr Hastey also requested more signage be placed with the speed limit.

HEAD START BUILDING-Andy Kober

Mr Kober requested that the Town get a lease agreement with the county to use the Head Start Building as an Ambulance station.

Per conversation with Carol Silva the county has a significant amount of collected SPLOST funding to begin to act now on getting a station/new ambulance in Pine Mountain. The SPLOST money can be used for the station and ambulance not the salaries.

Mayor Teel asked Ms Barbara to contact the affected parties and let them know the direction in which the Town is moving in concerning the property.

Mr Teasley made a motion to put the deed in the name of the Town, subject to Ms Barbara getting input from the affected parties and reporting back to Mayor Teel as to whether this is satisfactory.

Mr Kober seconded the motion.

Mr Trott, Ms Ewell and Ms Pierce voted in favor of the motion.

GAS LOG SHEETS-Mayor Teel

Mayor Teel requested that the gas log sheets be turned into Betsy at the end of the month.

FURTHER INFORMATION ON PINE MOUNTAIN/HARRIS COUNTY EMS STATION-Wayne Hollaway

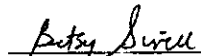

Mr Teasley made a motion that the meeting be adjourned.

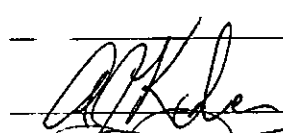
Ms Ewell seconded the motion.

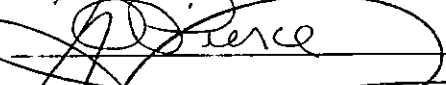
Mr Trott, Ms Pierce and Mr Kober voted in favor of the motion.

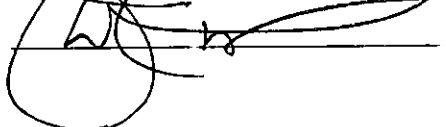
