Mr Howell was not in attendance.

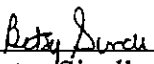
ADJOURNMENT

Lee Hale, Acting President, for the Pine Mountain Chamber of Commerce expressed an interest in attending the Council meetings.

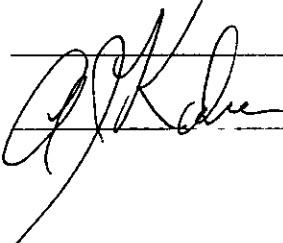
