APPOINT VANCE MORRIS AS MUNICIPAL ELECTIONS ABSENTEE BALLOT MANAGER

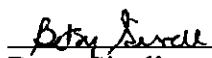
Mr Trott made a motion to appoint Vance Morris as Municipal Elections Absentee Ballot Manager.

Mr Kober, Ms Ewell and Ms Pierce voted in favor of the motion.

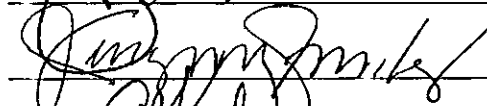
ADJOURNMENT

Thereafter, the meeting was adjourned.

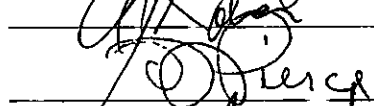
