Mr Antonio Abreu does not have liability insurance, however, he has a liability release form that has to be signed by everyone that participates.

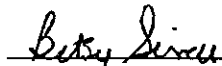
Ms Ewell made a motion to grant permission pending approval of the form from the Town's Attorney, Ron Mullins.

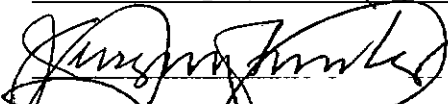

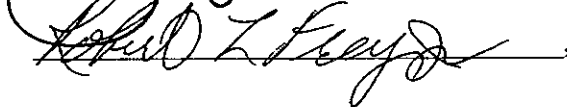
