Mr. Frey seconded the motion.

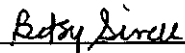
Ms. Ewell and Ms. Pierce voted in favor of the motion.

Marcie Harcey**

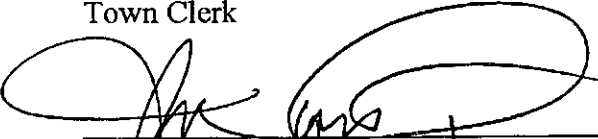
Ms. Harcey requested that the money from the Tourism Grant be used to purchase Christmas decorations/lights for the wreaths over lamp posts.

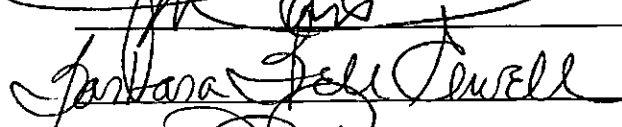
Mayor Teel advised Ms. Harcey that the money was already being used for something else.

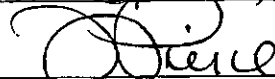
Thereafter, the meeting was adjourned.

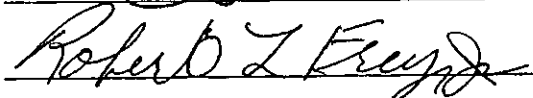
