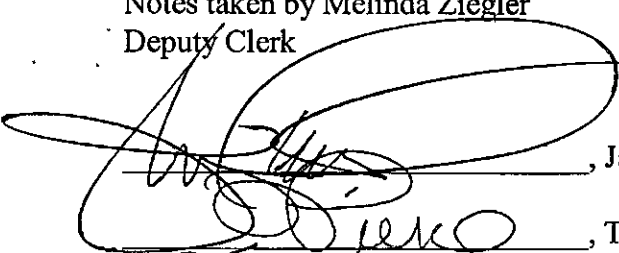
PARKING LICENSE AGREEMENT-David H. Aldrich Community Life Center-Harold Tarpley

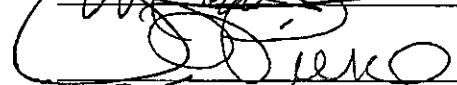
Mr. Trott made a motion to approve the Parking License Agreement between the Town of

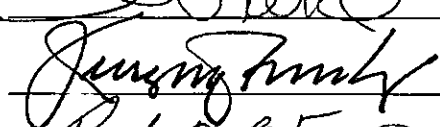
Pine Mountain and the David H. Aldrich Community Life Center, Inc.

Mr. Aldrich abstained.

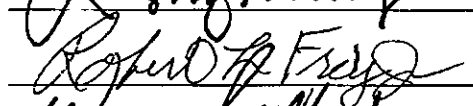
Thereafter, the meeting was adjourned.

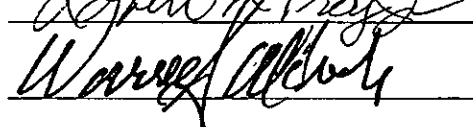
