RESOLUTION TO PERMIT AND REGULATE SALES OF DISTILLED SPIRITS OR ALCOHOLIC BEVERAGES FOR BEVERAGE PURPOSES BY THE DRINK ON SUNDAYS BETWEEN 12:30 P.M. AND 12:00 MIDNIGHT IN ANY LICENSED ESTABLISHMENT WHICH DERIVES AT LEAST 50 PERCENT OF ITS TOTAL ANNUAL GROSS SALES FROM THE SALE OF PREPARED MEALS OR FOOD IN ALL THE COMBINED RETAIL OUTLETS OF THE INDIVIDUAL ESTABLISHMENT WHERE FOOD IS SERVED AND IN ANY LICENSED ESTABLISHMENT WHICH DERIVES AT LEAST 50 PERCENT OF ITS ANNUAL GROSS INCOME FROM THE RENTAL OF ROOMS FOR OVERNIGHT LODGING AND TO PERMIT AND REGULATE PACKAGE SALES BY DULY LICENSED RETAILERS OF MALT BEVERAGES, WINE AND DISTILLED SPIRITS ON SUNDAYS BETWEEN THE HOURS OF 12:30 P.M. AND 11:30 P.M. UPON APPROVAL BY THE MAJORITY OF THE VOTERS OF THE TOWN OF PINE MOUNTAIN, GEORGIA AND TO REQUEST THAT THE ELECTION SUPERINTENDENT ISSUE A CALL FOR AN ELECTION FOR THE PURPOSE OF SUBMITTING THE QUESTIONS OF SUCH SUNDAY SALES TO THE ELECTORS OF THE TOWN OF PINE MOUNTAIN FOR APPROVAL OR REJECTION-Mayor Teel
